Company Code of Conduct	The Code of Conduct sets down the actions and behavior expected of employees when representing the Company.
Action for employees if slavery and / or trafficking is suspected	<i>Any member of staff who suspects that an individual is being held in slavery, or is being trafficked, should inform the relevant authorities. In the first instance, this is the Police on 999 (if it is an emergency) or 101 if not. Alternatively, staff can call Crimestoppers on 0800 555 111 if they want to stay anonymous. Due Diligence Processes for Slavery and Human Trafficking	<p>The Company undertakes due diligence when considering taking on new suppliers and regularly reviews its existing suppliers. The Company's due diligence process includes building long-standing relationships with suppliers and making clear our expectations of business partners and evaluating the modern slavery and human trafficking risks of each new supplier and invoking sanctions against suppliers that fail to improve their performance in line with an action plan provided by us, including the termination of the business relationship.</p> <p>This Modern Slavery and Human Trafficking Statement will be regularly reviewed and updated, as necessary. The Director of A&S Recruitment Limited endorses this policy statement and is fully committed to its implementation.</p>
